The bid security guarantee shall conform to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 2075/10/08 (22nd Jan, 2019) at the Chhipaharmai rural Municipality Office, Parsa. Bids must be valid for a period of 45 days i.e. 2075/11/23 (07th Mar 2019) after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid i.e. 2075/12/23 (6th Apr. 2019)
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
